

Call for Nominations for the 2017 Exemplary Service Award

Purpose

- The purpose of this award is to recognize exemplary service to the Association of Professional Geoscientists of Nova Scotia (APGNS, Geoscientists Nova Scotia).
- This award may be in recognition of long term service or a major concerted effort for a particular project or event or activity.

Eligibility for the Award

- All categories of registration / membership (member, retired member, honorary life member, life member, member-in-training, license to practice, or Certificate of Authorization) are eligible to be nominated for this award.
- The individual / corporation must be a member of the Association during the period of service and a current member-in-good-standing at the time of the award.
- A person cannot be nominated who has disciplinary proceedings initiated or pending.
- Any member-in-good-standing may nominate another member.
- Serving Councillors, members of the Executive Committee and employees or contractors are not eligible for the award but may nominate others.

Criteria for Selection

- A nominated member must have evidence of exemplary long service or special service for a particular activity in his/her work for the Association.
- Examples of work for long term service might be one or more of the following:
 - member of Council; more than one term;
 - member of the Executive Committee;
 - member of a Board, special committee or task force;
 - event(s) organizer; and/or
 - serving as the director / representative of the Association at national meetings of Geoscientists Canada or other national groups.

- No amount of service time is implied by the award. The Award Committee will decide each year what constitutes the appropriate amount / level of service to be considered eligible for the exemplary service award and make a recommendation to Council for approval.

Submission of Nomination

- Submit the name and nomination details to the Awards Committee using the nomination form.
- All submissions must be postmarked or received prior to the deadline.

Deadline

- Nominations must be received **by Friday, March 17, 2017.**
- Presentation will be made at the Annual General Meeting on April 27, 2017.
